Privacy Policy

Original Innovation Group ("we", "us", "our") values your privacy and is committed to protecting your information.

This Privacy Policy explains how Pokka collects, uses, and protects your personal information when you access or use our website, web application, and related digital wallet services powered by Crossmint and built on Base blockchain.

1. Information We Collect

We collect the minimum amount of personal information necessary to operate our platform and provide our services. This may include:

- Your email address (for login and notifications)
- Your wallet address (non-custodial)
- Optional account metadata such as nickname or project name

We **do not** collect passwords, seed phrases, or private keys. Pokka wallets are non-custodial and are under your sole control.

2. Wallet and Passkey Security

Wallets in Pokka are created using Crossmint's non-custodial wallet infrastructure. You, as the user, are solely responsible for:

- Safely storing your passkey or linked device access
- Managing your recovery options via your device or identity provider

We cannot and do not store, access, or recover your wallet credentials.

If you lose your access device (e.g., phone, Face ID, or platform credential), your wallet may not be recoverable.

3. How We Use Your Data

We use collected data to provide, operate, and improve the Pokka platform. Specifically:

- To enable login, authentication, and access to your wallet
- To manage wallet-related features like transaction history, balances, and NFT purchases
- To respond to your support requests and enhance your experience

We do not sell, rent, or share your data for advertising or marketing purposes.

4. Data Storage and Security

All data is stored using industry-standard safeguards, including encryption, protected access, and secure infrastructure.

We store only the essential information needed to provide support or enforce service integrity.

Examples:

- Your email address may be stored securely to assist you with login issues
- Your wallet address may be stored for transaction history or internal analytics

5. Use of Third-Party Services

We rely on trusted third-party providers to deliver our core functionality:

- Crossmint for wallet creation, identity authentication, and NFT payment processing

- Base Blockchain to confirm and record your transactions on-chain

6. Data Retention

We retain your personal data only as long as necessary to:

- Provide you with Pokka services
- Comply with legal obligations or audits
